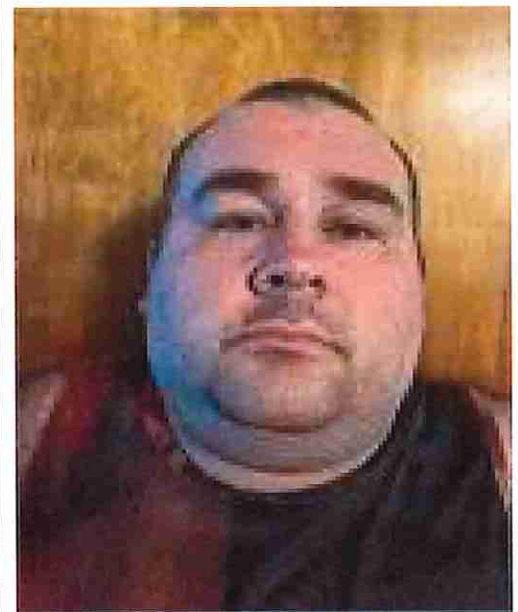

**SUMMARY OF INCIDENT:** An arrest warrant shall be attached when applicable excluding Juvenile/Child warrants.

On 05/21/2026 at approximately 1655 hours, the above accused, Ryan Pulcini, was located and taken into custody on the strength of an active Arrest Warrant. Pulcini was processed according to State Police Policy and Procedures under UAR #1742027 and subsequently charged with violating Connecticut General Statutes 14-222a Negligent Homicide with a Motor Vehicle and 14-236 Failure to Maintain Proper Lane. Pulcini was released on a \$100,000 Non-Surety Bond as set by Sgt. Ryan #278. Pulcini is set to attend court, GA-09 Middletown Superior Court, on 06/18/2026 at 0900 hours.
